## SECTION 4 : FIRST AID MEASURES

### 7.1. Precautions for safe handling

#### Suitable technical inspections

- Ensure adequate ventilation, if possible with extractor fans at work posts and appropriate general extraction.
- Personnel shall wear regularly laundered overalls.

#### Personal protection measures, such as personal protective equipment
